Procedure for Electing Officers

Discussion was had regarding the procedure for the election of officers. Jeff Jones advised that a number of societies have a non-binding policy to reflect that the Vice President elected in one year will become the President in the next year, allowing for a new President. This is common in many non-profit groups and professional organizations. It permits other people to have a turn at both Vice Presidenmimijhbvvbt and President; it is democratic; it avoids having to have an election between

two or more people; it builds capacity of local volunteers to gain experience in local governance. Discussion was had regarding this proposal.

Motion: that the MCAPs adopt a non-binding policy that:

- 1. The President and Vice President shall be for a one year term;
- 2. The Vice President elected in one year will automatically become the President in the following year without requiring an open election for President;
- 3. A new Vice President shall be elected in each succeeding years for a one year term, and shall become the President for the following year;
- 4. The position of Secretary shall remain a yearly elected position;

Motion carried by consensus.
